- (A) To corporate, collaborate and enter into such agreements with Trust, Societies, Association, Institutions and any other bodies whether national or international, that may help in the pursuance of all or any of the trust objects.
- (B) To acquire by gifts, purchases, exchanges, lease, hire or otherwise howsoever, any land, buildings, apartments, right of common play grounds parks and property moveable or immovable and any estate or interest; for the furtherance of all or any of the objects of the Trust.
- (C) To build construct and maintain buildings, hostel, houses, other buildings or any other immovable property belonging to or held by the trust and alter, extend, improve, repair, enlarge or modify the same including any existing buildings and to provide and equip the same with light, water, drainage, furniture, fittings, instruments, apparatus and appliances and all other necessities for the use to which such buildings are to be put up or held.

- (D) To sell, mortgage, let, lease, exchange, gift, and otherwise transfer or dispose of or deal with all or any property movable or immovable of the trust for the furtherance of the objects of the trust.
- (E) To give remuneration, pension or gratuities to teachers, staff and other employees and to make payments towards insurance and to form and contribute to provident and other funds for the benefit of the person employed by the trust.
- (F) To borrow and raise money without security or on the security of mortgage, charge or hypothecation or pledge over all or any of the immovable or movable properties belonging to the trust or in any other manner whatsoever from any bank, financial institution, corporate body or any other person of the furtherance of the objects of the trust.
- (G) To pay out of the funds belonging to the Trust or out of any particular part of such funds all types of money borrowed, all expenses of or incidental to the formation of the Trust and towards management and administration of any of the foregoing objects and activities including all rents, rates, taxes, outgoing and the salaries of the employees etc.
- (H) To invest and deal with any money of the Trust not immediately required for any of its objects in such manner as may be thought fit and proper by the trustees from time to time and allowable under law.

- (I) To appoint Bankers and to draw, accept, endorse and discount cheque, notes or other negotiable instruments.
- (J) To undertake and accept the management of any endowment or trust fund or donation.
- (K) To join corporate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having similar nature & objects.
- (L) To take over or amalgamate with any other charitable trust, society or institution with similar objects.
- (M) To do all non-political, legal and peaceful acts and undertake other activities which may help to promote the objects of the trust and are incidental and conducive to the attainment of any of the objects of the trust.

5 .THE TRUSTEES:

The Trustees shall consist of the following categories of Trustees:

- (i) **Founder Trustee / Whole Life Trustees:** As mentioned herein before in the trust deed the trustees so Mentioned will be the founder trustees. The founder trustees of the trust shall be the life trustees of the trust and after death of any founder trustee legal heirs shall be lifetime trustee of the trust.

The founder trustees can assign their trusteeship to others; however, such new induction will only be with the consent of all remaining trustees. Provided further that the Founder Trustee shall have life term and shall not be liable for retirement or removal





from the Trust till he voluntarily retire or become legally incompetent to be a trustee. The founder trustee will have right to attend, participate and vote in Annual General Meeting of Board of Trustees.

The founder trustees will be extended up to only. The founder trustee will be taken with the consent of all whole life founder trustees as mentioned in this deed above.

(ii) **Nominated Trustees:** Founder Trustee if deem fit in the best interest of the Trust may appoint nominated representatives of certain like minded public and charitable institutions. The Founder members will designate the institution as well as number of person that the designated institution may sent to be trustee of that trust. These trustees will be called as nominated trustee and will cease to be trustee of that trust if the designated institution take their name back and if founder members found him engaged in work that is against the interest and objects of the Trust. The Founder Trustee at any point of time may withdraw the designation so granted to any institution.

The nominated trustees will not be eligible to attend the Annual General Meeting of Board of Trustees.

(iii) **Trustee patron:** The founder trustees keeping in mind the best interest of trust will elect patron trustees. The Trustee patron will not be eligible to attend the Annual General Meeting of Board of Trustees.




(iv) **Trustees Scholar:** The Scholar trustees will also be elected by the founder members. The scholar trustees can be those people who are eminent personalities in their own field or who have provided valuable services to the community or the nation. The intention for such appointment is to give honor to these personalities as well as to get the privilege of their association to the trust. Founder trustees can define the tenure of such trustees. The Trustees Scholar will not be eligible to attend the Annual General Meeting of Board of Trustees.

(v) Any person shall cease to be a trustee if (a) he without leave of absence does not attend five consecutive meetings of the Trust or remain out of meetings consecutively for five months, which ever is longer (b) he is requested to resign by 100% of trustees of the Trust. This clause will however not be applicable on Founder Trustees.

(vi) Any trustee being an Engineer, Doctor, Lawyer, Chartered Accountant, Scientist, Researcher or any other person engaged in any profession or business shall be entitled to be paid all the usual professional fees etc. for time extended, business transacted and act done by him or any of his partners (including act which a trustee not being in any profession or business could have done personally) in spite of the fact that he shall be a trustee of these presents.

6. BOARD OF TRUSTEES.

The board of trustees will be highest authorities to govern, control and manage the whole of affairs of the trust as well as properties of the trust and to take decisions in respect of running and even closure of the trust. All the whole life trustees will collectively form the "Board of Trustees".




7. ANNUAL GENERAL MEETING / EGM OF THE BOARD OF TRUSTEES


vi) The board of trustees will transact the following ordinary business during the Annual General Meeting.


8. POWERS OF THE BOARD


The Board of trustees shall have the following powers and in ordinary course will confer all the powers to the governing body to handle the affairs of the trust, smoothly and effectively.

- a) To accept donation, contribution, grants, subscriptions in cash or in kind from any person, company, Bank firm, association, association of persons, HUF or family trust or trusts or corporate body from govt. or cooperative society for the furtherance of the objects of the trust.
- b) To manage the properties and other assets of the trust and to do all such acts necessary for the preservation, maintenance and management of the trust and the trust properties.
- c) To sell or give on rent or on hire or lease or any immovable or movable properties of the trust for such period or periods on such terms and conditions as the trustees may think fit and proper.
- d) To invest trust funds or properties whether representing the corpus or income in such investments as the trustees shall think fit and proper in pursuance to the provision of the income tax act.
- e) To borrow or raise loans (with or without securities) on such terms, such security and rate of interest etc. as the board determines, from any bank, financial institutions, corporate body or any other person for carrying out the objects of the trust.
- f) To let out, lease sub-lease, mortgage, demise or other wise deal



- j) That the trustees are authorized to give guarantees of the assets and property of the trust including the bank guarantee and the security to the corporate bodies person (s) firm (s) institution (s) trust as they may deemed fit from time to time. The trustees shall not be personally liable for such guarantees or securities otherwise than for their willful negligence.





The trust shall no be accountable/ held responsible for any acts/ deeds of the trustees in their individual capacities.



- f) To act as the supreme and final authority for all purposes and objectives of the trust.


